# Novel features of telomere biology revealed by the absence of telomeric DNA methylation

Cytosine methylation regulates the length and stability of telomeres, which can affect a wide variety of biological features, including cell differentiation, development, or illness. Although it is well established that subtelomeric regions are methylated, the presence of methylated cytosines at telomeres has remained controversial. Here, we have analyzed multiple bisulfite sequencing studies to address the methylation status of *Arabidopsis thaliana* telomeres. We found that the levels of estimated telomeric DNA methylation varied among studies. Interestingly, we estimated higher levels of telomeric DNA methylation in studies that produced C-rich telomeric strands with lower efficiency. However, these high methylation estimates arose due to experimental limitations of the bisulfite technique. We found a similar phenomenon for mitochondrial DNA: The levels of mitochondrial DNA methylation detected were higher in experiments with lower mitochondrial read production efficiencies. Based on experiments with high telomeric C-rich strand production efficiencies, we concluded that *Arabidopsis* telomeres are not methylated, which was confirmed by methylation-dependent restriction enzyme analyses. Thus, our studies indicate that telomeres are refractory to de novo DNA methylation by the RNA-directed DNA methylation machinery. This result, together with previously reported data, reveals that subtelomeric DNA methylation controls the homeostasis of telomere length.

Telomeres guarantee the complete replication of chromosomal termini, prevent genome instability, and influence relevant systemic processes like aging, cancer, or illness (Blackburn 2010). The length of telomeres and the chromatin organization of telomeric regions influence telomere functions. Hence, the epigenetic marks that label telomeric regions, which include telomeres and subtelomeres, play important roles in telomere biology (Blasco 2007; Galati et al. 2013; Giraud-Panis et al. 2013).

One of the major epigenetic signatures found in eukaryotes is cytosine methylation. This DNA modification regulates multiple processes in plants and animals, including the homeostasis of telomere length (Blasco 2007; Suzuki and Bird 2008; Ooi et al. 2009; Law and Jacobsen 2010; Castel and Martienssen 2013; Ogrocká et al. 2014; Vaquero-Sedas and Vega-Palas 2014). Mammalian DNA methylation is primarily found in the CG context (Ramsahoye et al. 2000; Lister et al. 2009). In contrast, plants have significant levels of DNA methylation in all sequence contexts (CG, CHG, and CHH, where H can be A, C, or T) (Law and Jacobsen 2010).

Although subtelomeric DNA methylation has been reported in animals and plants, the presence of DNA methylation at telomeres remains an open question in both kingdoms (Blasco 2007; Vrbsky et al. 2010; Vaquero-Sedas et al. 2011; Ogrocká et al. 2014). The methylation status of mammalian telomeres has not

been investigated because, as mentioned above, mammals have low levels of non-CG methylation, which is the type of DNA methylation that should be associated with telomeric sequences (CCCTAA in mammals and CCCTAAA in plants). In turn, although the methylation levels of plant telomeres have been studied by different groups, they remain controversial (Vrbsky et al. 2010; Majerová et al. 2011a,b; Vaquero-Sedas and Vega-Palas 2011a,b; Vaquero-Sedas et al. 2011, 2012; Ogrocká et al. 2014). Therefore, it is important to settle the methylation status of telomeres.

The experimental analysis of the epigenetic marks that label telomeres is complicated by the influence of subtelomeres and/or the Interstitial Telomeric Sequences (ITSs), which are usually present at pericentromeric regions and subtelomeres (Vaquero-Sedas and Vega-Palas 2011b). On the one hand, telomeres and subtelomeres cannot be differentiated by microscopy techniques. On the other hand, ITSs can interfere with the analyses of telomeric chromatin structure by chromatin immunoprecipitation followed by hybridization with a telomeric probe. Moreover, ITSs might be identified as telomeres in massively parallel DNA sequencing studies (Vaquero-Sedas et al. 2012; Vega-Palas and Vaquero-Sedas 2013). Hence, the analysis of the epigenetic modifications present at telomeres should be carefully designed.



DNA. We detected higher levels of unconverted mitochondrial cytosines in experiments with lower mitochondrial read production efficiencies (Fig. 3A). In addition, we also observed higher levels of unconversion in cytosines with lower read coverage in all the experiments analyzed (e.g., Fig. 3B). These results lead us to conclude that the methylation levels of telomeres should be better estimated from the experiments with the high telomeric C-rich strand production efficiencies.


Before further analyzing the methylation status of *Arabidopsis* telomeres, we decided to investigate telomeric production efficiency and cytosine unconversion in DNA methylation mutants. We analyzed several mutants affected in CG, CHG, and CHH methylation. These mutants were altered in DNA methyltransferases or chromatin remodeling proteins. Among the DNA methyltransferase mutants were *met1-3*, *cmt2*, a double *met1-3*, *cmt3-11* mutant, and a triple *drm1-2*, *drm2-2*, *cmt3-11* mutant. Among the chromatin remodeling mutants were *ddm1-2*, *drd1-7*, and a double *ddm1-2*, *drd1-7* mutant. Previous results have shown that DNA methylation is affected at a genome-wide level in all these mutants. Whereas CG methylation is catalyzed by MET1, non-CG methylation is catalyzed by CMT3 (CHG) and DRM1, DRM2 or CMT2 (CHH and also CHG). These DNA methyltransferases access DNA with the help of chromatin remodeling proteins like DDM1 and DRD1 (Vongs et al. 1993; Finnegan et al. 1996; Ronemus et al. 1996; Jeddeloh et al. 1999; Bartee et al. 2001; Lindroth et al.

2001; Cao and Jacobsen 2002a,b; Law and Jacobsen 2010; Stroud et al. 2013; Zemach et al. 2013).


Not surprisingly, we found that the percentage of unconverted cytosines in 50TRs and the percentage of 50TRs containing cytosines detected in all the methylation mutants varied with the telomeric C-rich strand production efficiency (Fig. 2). Hence, these results confirmed that the methylation status of telomeres is confounded by experimental limitations of the bisulfite technique.


**Figure 4.** A synthetic nonmethylated telomeric DNA template is not fully converted during bisulfite treatment. (A) Scatter plot representations of the percentages of unconverted cytosines (Cs) within 50TRs and of 50TRs containing cytosines versus the telomeric strands ratio. Ratio values were calculated as the number of 50TRs divided by the number of reads that follow the TTTAGGG pattern along the first 50 bp. They were expressed as percentages. Whole-genome bisulfite sequencing studies performed with the *Arabidopsis* wild-type strain (red dots) and with DNA methylation mutants (blue dots) were analyzed. Similarly, bisulfite sequencing experiments performed with a 105-bp-long telomeric synthetic fragment at 54°C (light green dots) or at 40°C (dark green dots) were also analyzed. Data corresponding to the *met1-3*, *cmt3-11* and *ddm1-2*, *drd1-7* double mutants are indicated. (B) Bar plot representation showing the distribution of cytosines within 50TRs derived from the synthetic telomeric fragment treated with bisulfite at 54°C (light green bars) or at 40°C (dark green bars). The percentages of 50TRs containing different numbers of cytosines are represented. Average values corresponding to four independent experiments are shown for each temperature.

The double *met1-3*, *cmt3-11*, and *drm1-2*, *drd1-7* mutants have been shown to lack significant levels of CHH methylation. However, we detected telomeric DNA methylation in these mutants, which revealed that their telomeric DNA was not fully converted by bisulfite. To further explore conversion efficiencies, we performed bisulfite sequencing experiments using a synthetic nonmethylated telomeric DNA template. We used two different temperatures (54°C and 40°C) during the bisulfite treatment step. The percentage of unconverted cytosines detected in these experiments was ~1% at 54°C and 2.3% at 40°C, revealing that bisulfite conversion was more effective at higher temperature (Fig. 4A). These data demonstrate that the experimental conditions influence the degree of telomeric cytosine conversion.

We next wanted to address why high levels of cytosine methylation were estimated from some of the *Arabidopsis* bisulfite sequencing studies. Two different kinds of 50TRs could be detected in all the *Arabidopsis* studies according to their cytosine content: those with a low content of cytosines, and those with a high

content (Fig. 5A). This kind of distribution has been previously observed after bisulfite treatment of nonmethylated phage DNA (Guo et al. 2013). Although phage reads with few cytosines were proposed to originate from random bisulfite conversion failure or sequencing errors, phage reads with high content of cytosines were thought to arise from secondary structure formation and overall failure of bisulfite conversion (Guo et al. 2013).


We observed that the low telomeric C-rich strand production experiments generated higher percentages of 50TRs with a high content of cytosines than the high production experiments (Fig. 5A). These results support the hypothesis that the low production efficiency experiments might be related, at least in part, to secondary structure formation and overall failure of bisulfite conversion of the *Arabidopsis* telomeric DNA. Indeed, we found a strong positive correlation between the percentage of unconverted cytosines detected within 50TRs or mitochondrial reads and the percentage of unconverted reads using BS-Seeker2 (Fig. 5B; Guo et al. 2013).

We next decided to analyze the production efficiency of the telomeric template DNA strands. We found that the telomeric C-rich strand was produced with lower efficiency than the G-rich strand (Fig. 4A). In addition, we also found this telomeric strand imbalance in the experiments performed with *Arabidopsis* genomic DNA, although it was more pronounced in this latter case. Although the levels of unconverted cytosines at *Arabidopsis* telomeres were lower in experiments with lower strand imbalance, the levels of unconverted cytosines detected for the synthetic template did not decrease with the ratio of the telomeric strands (Fig. 4A). These results could be explained if we assume that the telomeric template had a lower tendency to remain double stranded or to form secondary structure than the *Arabidopsis* telomeric fragments during bisulfite experiments. This assumption is supported by the fact that unconverted cytosines do not tend to accumulate within the same telomeric template reads and by the virtual absence of telomeric template reads with a high density of cytosines (Fig. 4A,B). The nature of the synthetic telomeric template could have influenced its capability to remain double stranded or to form secondary structures as it was synthesized by annealing two telomeric oligos and, most importantly, was shorter (105 bp) than the *Arabidopsis* DNA fragments analyzed in the whole-genome bisulfite sequencing studies (typically several hundred bp).

We found that cytosines within mitochondrial DNA regions with high CG density had a higher tendency to be unconverted and, to a lesser extent, uncovered than cytosines within low CG density regions (e.g., Fig. 6A). This tendency was particularly

evident in experiments with high levels of total mitochondrial unconverted cytosines (Fig. 6B). It will be interesting to ascertain whether high CG density regions have a high propensity to remain as double-stranded DNA or to form noncanonical secondary structures during bisulfite experiments.

### High-confidence data reveal the absence of DNA methylation in *Arabidopsis* telomeres

As mentioned above, the experiments with high telomeric C-rich strand production efficiencies should better represent the methylation status of *Arabidopsis* telomeres. Indeed, these experiments revealed that *Arabidopsis* telomeres are not methylated or undergo very low levels of DNA methylation (Fig. 2). We focused on the only high C-rich strand production efficiency study analyzed here that generated reads longer than 50 bp (Supplemental Table S1). The Sequence Read Archive accession number of this experiment is SRR578938 (Zemach et al. 2013). The percentages of unconverted cytosines within 50TRs and of 50TRs containing cytosines detected in SRR578938 were 1.5% and 10%, respectively (Fig. 2). Hence, the levels of telomeric cytosine methylation estimated from SRR578938 are within the technical background levels achieved for the whole genome in bisulfite experiments (Lister et al. 2008).

Since the reads from SRR578938 were 100 bp in size, we decided to use the complete sequence of all the 50TRs from this experiment to map their genomic origin. We found that all the 50TRs mapped to telomeres, to ITSs, or to the left telomere-subtelomere junction of Chromosome I (Fig. 7; Supplemental Fig. S1). Most


of the telomeric reads detected lacked cytosines along their entire length (Fig. 7; Supplemental Fig. S1). In contrast, the reads corresponding to ITSs or to the telomere-subtelomere junction of Chromosome I exhibited high levels of cytosines, which is in agreement with the high levels of DNA methylation previously reported for these loci (Fig. 7; Cokus et al. 2008; Vrbisky et al. 2010; Vaquero-Sedas et al. 2011, 2012; Ogrocká et al. 2014). Thus, the analysis of the complete 100-bp reads from SRR578938 confirms the virtual absence of DNA methylation in *Arabidopsis* telomeres.

### Restriction enzyme sensitivity analyses confirm the absence of DNA methylation in *Arabidopsis* telomeres

To verify our *in silico* analyses, we decided to study DNA methylation at *Arabidopsis* telomeres using an alternative technique. We performed Southern blot hybridization experiments using three restriction enzymes with different DNA methylation dependence/sensitivity. One of the enzymes (HpaII) recognizes and cuts the sequence CCGG only when both cytosines are unmethylated. The other two enzymes (McrBC and FspEI) recognize methylated cytosines and cut the surrounding nucleotides. McrBC recognizes the sequence  $R^mC_{(N40-3000)}R^mC$  and should target the first cytosine of the telomeric repeat unit (CCCTAAA) if it were methylated. FspEI recognizes the sequence  $C^mC$  and should target the second and third cytosines of the telomeric repeat unit if they were methylated (Fig. 8A).

We digested equal amounts of *Arabidopsis* genomic DNA with the restriction enzyme Tru9I or with Tru9I plus one of the enzymes mentioned above. We then ran the resulting DNA samples on an agarose gel and hybridized them with a telomeric probe or with a centromeric probe. Tru9I recognizes and cuts the sequence TTAA, which localizes in subtelomeric regions at ~200 bp from the perfect telomeric repeats, on average. Therefore, this enzyme cuts the *Arabidopsis* genome frequently, but leaves telomeres essentially uncut. We observed a 2- to 5-kbp fuzzy telomeric band after digesting *Arabidopsis* genomic DNA with Tru9I, as previously reported (Richards and Ausubel 1988; Fitzgerald et al. 1999; Vaquero-Sedas et al. 2011). This telomeric band remained unaffected after digestion with HpaII, FspEI, or McrBC (Fig. 8B,C). In contrast, three centromeric DNA bands generated after Tru9I digestion were readily digested with FspEI and McrBC, as would be expected due to the high levels of DNA methylation previously observed for the centromeric repeats. As expected, these bands remained unaffected in the presence of HpaII (Vongs et al. 1993; Lindroth et al. 2001). Although these results cannot completely rule out the existence of a very minor portion of methylated telomeres, we should consider that a single cut within a telomeric fragment should shorten this fragment. In addition, the very low proportion of 50TRs containing one or two unconverted cytosines

These aberrant cytosines might still be recognized as cytosines but undergo amplification with less efficiency than uracil during the first cycle of PCR. Alternatively, these aberrant cytosines might be amplified efficiently during the first cycle of PCR but incorrectly copied. Such phenomena might explain the anti-correlation observed for the telomeric C-rich strand production efficiency and the unconversion of cytosines at *Arabidopsis* telomeres.

The third cytosine of the *Arabidopsis* telomeric repeat unit has been found to be unconverted more frequently than the first and second cytosines after bisulfite treatment (Cokus et al. 2008). This cytosine is unconverted more frequently than the first and the second in the 50TRs originating from the double *met1-3*, *cmt3-11* and *ddm1-2*, *drd1-7* mutants, which lack significant levels of asymmetric DNA methylation (Supplemental Fig. S2; Stroud et al. 2013; Zemach et al. 2013). Hence, the lower conversion rate of this cytosine should result from experimental limitations like those mentioned above. The third cytosine of the *Arabidopsis* telomeric repeat unit is also unconverted more frequently than the first and second cytosines in subteleromic regions and ITSs of wild-type plants (Fig. 7; Cokus et al. 2008; Vrbsky et al. 2010; Ogrocká et al. 2014). However, these cytosines reflect real methylation events. Thus, taken together, our results suggest a special DNA conformation of the telomeric repeat arrays.


We hypothesize that incomplete telomere denaturation and/or telomeric secondary structure could prevent bisulfite conversion, enhance bisulfite driven DNA breakage, and/or alter the efficiency/accuracy of the first cycle of PCR amplification after bisulfite treatment. On the other hand, the efficient denaturation of telomeres and the absence of telomeric secondary structures

could favor cytosine conversion, although the conversion efficiencies achieved depend on different experimental parameters, such as the temperature of incubation with bisulfite.

### Telomeres are refractory to de novo DNA methylation

Our results indicate that DNA methylation is absent from *Arabidopsis* telomeres. However, subteleromic regions display a high level of cytosine methylation, which is in agreement with previously published results (Fig. 9A; Vrbsky et al. 2010; Vaquero-Sedas et al. 2011; Ogrocká et al. 2014).

Small interfering RNAs (siRNAs) can target DNA methylation in all sequence contexts through the RNA-directed DNA Methylation pathway (RdDM). This pathway involves multiple proteins including DNA and histone methyltransferases, chromatin remodeling proteins, RNases, and DNA or RNA polymerases (Law and Jacobsen 2010). Plants have two specific DNA polymerases involved in RdDM: pol IV and pol V. Pol IV together with the RNA dependent RNA polymerase 2 (RDR2) and the Dicer-like RNase 3 (DCL3) participates in the generation of 24-bp siRNAs. In turn, pol V, the siRNA single strand binding protein Argonaute 4 (AGO4) and the non-CG Domains Rearranged DNA methyltransferase 2 (DRM2) are required for siRNA-dependent DNA methylation. The RdDM pathway is involved in de novo DNA methylation. Through this process, siRNAs containing a specific nucleotide sequence are believed to drive DRM2-dependent DNA methylation of the same DNA sequence at different genomic loci. For example, 24-bp siRNAs containing perfect telomeric

repeats have been described in *Arabidopsis* (Gustafson et al. 2005; Vrbsky et al. 2010). These siRNAs drive RDR2, DCL3, AGO4, and DRM2-dependent DNA methylation of telomeric repeats at ITSs and subtelomeres (Cokus et al. 2008; Vrbsky et al. 2010; Stroud et al. 2013). However, we have shown here that the RdDM pathway cannot target DNA methylation at telomeres, which probably reflects their special architecture (Fig. 9A).

### Subtelomeric DNA methylation controls telomere length homeostasis

We have previously reported that *Arabidopsis* telomeres have lower levels of DNA methylation than ITSs or subtelomeres (Vaquero-Sedas et al. 2011). Here, we have described that DNA methylation is indeed absent from *Arabidopsis* telomeres. Notably, *Arabidopsis* mutants affecting CG and non-CG DNA methylation have shorter telomeres than wild-type plants (Ogrocká et al. 2014; Vaquero-Sedas and Vega-Palas 2014). Therefore, DNA methylation must be involved in the control of telomere length homeostasis in *Arabidopsis*. Since the expression of proteins that regulate telomere length have not been found to be altered in the aforementioned mutants (Zhang et al. 2006; Hudson et al. 2011), we conclude that subtelomeric DNA methylation positively controls the homeostasis of telomere length in *Arabidopsis* (Fig. 9). In contrast, DNA methylation controls telomere length negatively in mammals (Gonzalo et al. 2006). Thus, long telomeres are observed in mammalian DNA methylation mutants. However, these telomeres might arise after telomeric shortening, as previously reported for the *Saccharomyces cerevisiae est1* (ever shorter telomeres 1) survivors (Lundblad and Blackburn 1993). In addition, it is unknown whether the control of telomere length exerted by DNA methylation in mammals occurs at telomeres or subtelomeres (Blasco 2007).

Cytosine methylation has been related to a wide variety of biological features from the maintenance of genome stability to cell differentiation, development, or illness. Many of these features are also affected by telomere length (Osborne and Boubriak 2002; Ooi et al. 2009; Law and Jacobsen 2010; Guy et al. 2011; Bodelon et al. 2014; Heard and Martienssen 2014; Plasschaert and Bartolomei 2014). Hence, it will be interesting to ascertain the relevance of subtelomeric DNA methylation in all these processes in mammals and plants.

## Methods

### In silico analysis of telomeric DNA methylation

Data from different genome-wide bisulfite sequencing studies were analyzed (Schmitz et al. 2011; Ausin et al. 2012; Downen et al. 2012; Moissiard et al. 2012; Stroud et al. 2012, 2013, 2014; Zhong et al. 2012; Greenberg et al. 2013; Law et al. 2013; Zemach et al. 2013). Since the original Watson and Crick strands, but not their reverse complements, were sequenced in these studies, only the telomeric C-rich strand was monitored to estimate methylation levels. Therefore, the telomeric G-rich strand did not influence the methylation analyses. The Gene Expression Omnibus and the Sequence Read Archive accession numbers of the studies are indicated in Supplemental Table S1, together with the codes of the specific runs analyzed.

Considering that the length of the reads in many of the studies selected was 50 bp, we decided to start by studying only the first 50 bp of the reads in all the experiments even if they were longer. In principle, we considered telomeric reads as those that followed

the (YYTAAA)<sub>n</sub> pattern, where Y is C or T, along the 50 bp. These sequences could start at any nucleotide (C, T, or A) and corresponded to about seven methylated/unmethylated tandem telomeric repeats. We denoted these reads/fragment of reads as 50-bp Telomeric Reads (50TRs).

To verify that the 50TRs were generated essentially from telomeres, we determined the number of (YYTAAA)<sub>7</sub> nonoverlapping sequences in the *Arabidopsis thaliana* Col-0 genome, including ITSs and telomeres. First, we determined the number of these sequences at ITSs. We used the PatMatch tool in The *Arabidopsis* Information Resource (TAIR; <http://www.Arabidopsis.org>) and searched for the sequence (YYTAAA)<sub>7</sub> in the TAIR10 Whole-Genome (BAC clones) database, which contained 135,670,227 bytes. This search was performed using the default options that included searching in both strands with no mismatches allowed. The search resulted in 41 hits, from which only 31 were not repeated in different BAC clones. Six of the unique hits corresponded to sequences that were organized in tandem at the pericentromeric region of Chromosome III generating a 300-bp ITS composed of perfect tandem telomeric repeats. In addition, six of the hits were telomeric (five from pAtT51 and one from TEL3N). An alignment of the remaining 19 and the right border of the 300-bp ITS is shown in Figure 1. This alignment reveals that none of the 19 (YYTAAA)<sub>7</sub> aforementioned sequences are included in a DNA string containing more than 11 repeats.

Once we determined the number of ITSs containing the (YYTAAA)<sub>7</sub> sequence, we estimated the number of times that this sequence is found at telomeres. We estimated that telomeres contained about 765 nonoverlapping (YYTAAA)<sub>7</sub> sequences (3750 bp of average telomere length divided by 7 bp of the telomeric repeat unit and multiplied by 10 telomeres). Therefore, only ~3% of the (YYTAAA)<sub>7</sub> sequences are present at ITSs (25 divided by 765 and multiplied by 100). However, the percentage of 50TRs corresponding to ITSs in the bisulfite studies should be lower than 3% as the size of the DNA inserts used to construct the DNA libraries are typically 150–300 bp in size. Similarly, a low percentage of the 50TRs should correspond to the telomere–subtelomere junctions, which usually contain perfect telomeric repeats interspersed with degenerate repeats. In summary, if the bisulfite experiments work properly, we expect that at least 97% of the 50TRs correspond to telomeres.

To perform the analyses of cytosine methylation at telomeres we used an in-house computer program that allowed the identification of 50TRs, the determination of the number of unconverted cytosines within 50TRs, and the number of reads that followed the (TTAGGG)<sub>n</sub> pattern along the first 50 bp (Supplemental Table S1, Supplemental Telomeric analyses source code).

### In silico analysis of mitochondrial DNA methylation

Reads for the aforementioned *Arabidopsis* data sets were downloaded from the GEO repository and were mapped to the entire TAIR10 reference genome without allowing mismatches using BS-Seeker v2.0.32 (Guo et al. 2013), which calls Bowtie v0.12.9 (Langmead et al. 2009) in turn. Reads were not filtered for poor conversion prior to base calling. Counts of C and T base calls per mitochondrial cytosine for both strands were extracted from the resulting CG map files. Subsequent statistical analysis and plots were generated using a custom R environment (R Core Team 2008).

### Telomeric template synthesis, bisulfite treatment, library preparation, and next generation sequencing

Equal amounts of oligos containing the sequences (TTAGGG)<sub>15</sub> and (CCCTAAA)<sub>15</sub> were mixed, heated for 10 min to 98°C and

allowed to cool down for 15 min at room temperature. Then, the annealed DNA fragments were gel purified and their quality assessed using the D1000 assay on the TapeStation 2200 (Agilent Technologies). End repair, A-tailing, and adapter ligation was performed on the annealed oligos according to the Illumina TruSeq Nano kit protocol (catalog #15041759, Illumina). Adapter-ligated oligos were denatured in the presence of bisulfite (Zymo Lightning MagPrep, catalog #D5046, Zymo Research) for 8 min at 98°C, and two temperatures were used for the conversion step: 54°C (manufacturer's suggested temperature) and 40°C. Desulfonation was performed according to the manufacturer's instructions. Converted DNA was amplified using MyTaq Mix (Bioline, Taunton) and Illumina TruSeq PCR Primer Cocktail according to the following protocol: initial denaturation for 30 sec at 98°C; 12 cycles of 15 sec at 98°C, for 30 sec at 60°C, for 30 sec at 72°C; final extension for 5 min at 72°C. AMPure XP beads were used to clean up the final PCR reactions before sequencing. Libraries were sequenced with an Illumina HiSeq 2500 system using 100-bp single-end reads.

### Methylation-dependent restriction enzyme analyses of telomeric DNA methylation

Equal amounts of genomic DNA (500 ng) were undigested or digested with the restriction enzymes HpaII, FspEI, or McrBC following the supplier's instructions (New England Biolabs). The resulting DNA samples were purified, further digested with Tru9I, resolved on an agarose gel, transferred to a Hybond-N<sup>+</sup> membrane, and hybridized with a telomeric probe, as previously described (Gámez-Arjona et al. 2010). Then, the same membrane was stripped and hybridized again with a 180-bp centromeric repeat probe. The 180-bp centromeric template was synthesized as previously reported (Nagaki et al. 2003).
